

# Impact on companies I




- 93% of companies in the survey are directly affected by the Covid-19 crisis. This is only a minor change compared to June.
- Less uncertainty compared to June almost 80% can assess how the company will proceed in the next year.
- 3 out of 4 companies are in favor of the state financial support for companies, this is a slight increase to the first study. 46% stated that they would have liquidity bottlenecks without government aids. This is an increase of +26% compared to the firs survey.

#### How strongly is your company affected?








# Impact on companies II



- Sales and demand are the areas most affected by Covid-19. Overall, there is little improvement compared to last summer.
- Other negative impacts mentioned included **training**, **border closures/travel restrictions** and **basic operating conditions**.







### Government Support I



- Compared to last summer, the economic situation for the aerospace companies in our sample has not improved.
- Almost 65% of the companies in the survey still receive short-time working compensation.
- 1/4 of the companies receive another form of state support, such as Covid-19-credits.
- Despite the state support, almost **50% of the companies had to lay off jobs** because of the Covid-19 crisis.







## Government Support II



- A decreasing number of respondents believes that the government support is sufficient, while an increasing number finds it is too low.
- Also, an increasing number of companies are unwilling or unable to state their opinion on the matter.







## Recovery



- The majority of companies in our sample believe that it will take between 1 and 7 years (Median = 4.5 years)
  until the industry recovers to the 2019 level.
- Compared to last summer (Median = 3 years), the **estimated recovery takes 1.5 years longer**, with a much **smaller standard deviation**, meaning companies are less uncertain in estimating the longer recovery.








# About the Survey

- The samples are not completely identical as can be seen in the pie charts.








